ELIGIBILITY CRITERIA

- 1 Members of the public and Members of TTCSI may nominate eligible individuals, associations, affiliates, and organizations for the relevant award category, subject to the criteria for that category.
- 2 Nominations are open to all eligible service providers. State agencies are not eligible.
- 3 Companies must be registered in Trinidad and Tobago and at least 51% locally owned.
- 4 Nominated companies must provide a service identified under the CPC or UNCTAD classification.
- 5 Members shall not receive an award in the same category for two (2) consecutive years.
- 6 Members who received an award may be nominated in a different award category in the following year.
- 7 Individuals nominated for individual categories shall be considered Affiliate Nominees for the purpose of award classification

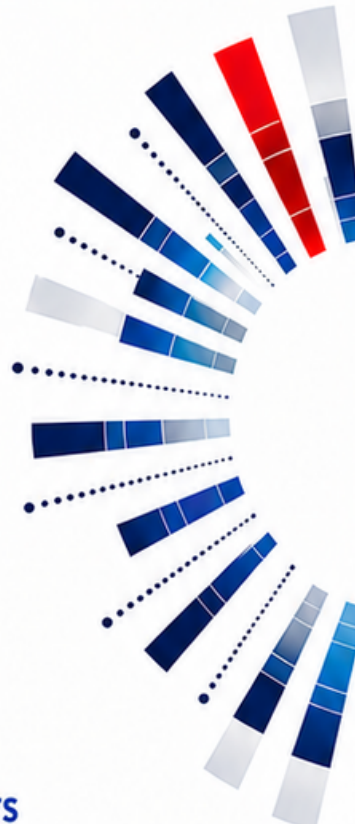

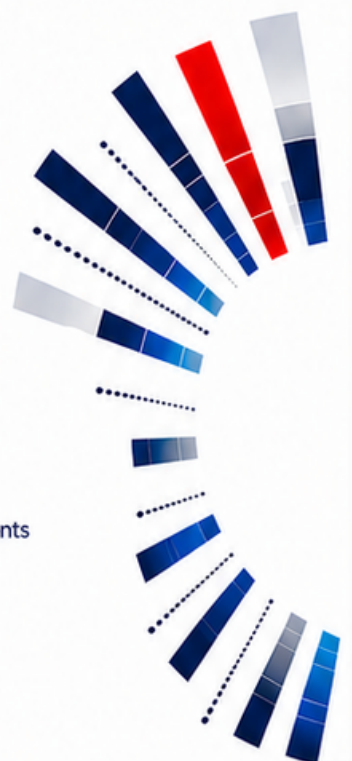
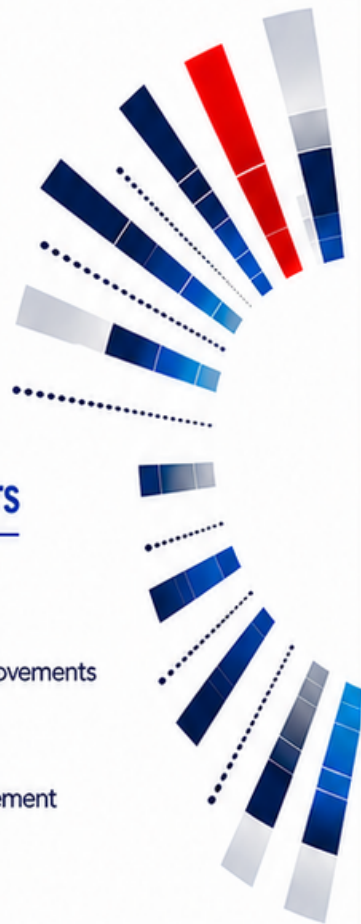
